

# List of charges for safe custody accounts, pension custody accounts and pledged custody accounts

Effective February 26, 2021

Here you can read about Danske Bank's general fees and charges for the safekeeping and registration of securities in custody accounts and for the services connected with their administration. The fees and charges are based on "Terms and conditions for custody accounts". Please contact the Bank if you require additional information on custody fees.

Generally, custody fees are subject to VAT, and all charges marked with an asterisk \*) are inclusive of VAT.

We charge custody fees half-yearly in arrears on May 31 and November 30. The fees are payable in June and December.

Please note that processing of custody account movements may generate several fees. Every time you pay a fee, you will receive a safe-custody fee note.

Annual custody fee – calculated separately for bonds and shares The fee is calculated monthly on the basis of the highest market value of the asset type. The market value is calculated monthly on the highest nominal holding during the month at the price prevailing at the end of the month. We then convert the market value into Danish kroner.
